

Loading Bays and Vehicle Passes

During the events Buildup and Breakdown
All Trucks will go to the Trucks Holding Area under the
Bridge where they will be issued and given with Different
Colored Gate Passes.

Each Color corresponds to a Specific Loading Bay.
The Drivers will proceed to the Designated Loading Bay
bay based on the Gate Pass Color.

Guidelines

Loading and Unloading (*Terms and Conditions*)

- Loading and Unloading must attend the holding area with vehicle registration card and location information .
- Loading and Unloading must completed within the allocated time; vehicles must leave after the allowed period (**Vehicles parking beyond the allocated time limit is liable to pay additional charges incurring on the excess time.**)
- Each Loading will have color code in the map , please make sure with location (Hall or VE door number to provide you the right access pass.
- Parking is prohibited at front side of VE doors, fire doors, lifts and yellow hashed areas.

Site Map with color Code










Must follow the first side of Build-Up and Break-Down Terms and Conditions.
This is based on a first-come first-served basis.

- All trucks must go to Holding area under the bridge First arrival to get the access pass to access **gate 7 for Loading Bay 4**, so we can ensure the smooth management of traffic in the loading bays.
- ALL drivers are to submit their vehicle registration card or driving licence, to issue the access pass with payment receipt.
- If the time limit is exceeded a fine will be imposed, Vehicles parking beyond the allocated time limit is liable to pay additional charges incurring on the excess time.
- Color code of the loading bay 4 for hall 10.2 to ICC 12 is **Green**
- ALL vehicles accessing the loading bays, must adhere to all ADNEC rules & regulations as says in the general information in the page 2 – 6 .

General Information

ADNEC Access Control Areas: Required documents (According to the UAE Labour Law)

- **Contractors and sub-contractors:**

Contractors who sub-contract must present official agreement in writing between two parties, under the official agreement of “Subcontract Agreement No.” (Official form is available at any UAE bookshop) and must be signed with the company stamp of the two parties in order to be accepted by ADNEC access control areas.

Note:

1. Organizers, Exhibitors and Contractors violating the UAE Labour Law policy will be sentenced to one month in jail plus fine of up to 50,000AED (per person).
2. The UAE Immigration Control Department make regular inspection at ADNEC.
3. ADNEC Security team is responsible for the access control to the building. Access will only be granted with proper identification requirements (valid Emirates ID + copy of temporary visa).
4. All rules and regulations must be strictly adhered to.


travelling to ADNEC

Guidelines

Contractor Badge :

Following Contractor Wristband regulations must follow at all times:

- Badge will be issued upon wearing complete PPE.
- Contractor must wear their Badge at all times while in ADNEC Location.
- Wristband must be visible at all times, chest area and on top of safety jacket or uniform.
- In case of Lost Badge, inform the Working Station Area; the Contractor will pay the charge of re-issue the Wristband which is **AED 25.00**.
