

IAAPA Expo Middle East 2026 Exhibitor Bulletin #2

Mandatory Stand Plan Review and Approval Process

All space-only, complex and double-deck stands must submit their booth layout and stand design through the [Exhibitor Resource Centre](#) for IAAPA review by **13 February 2026**. Once the design is approved, exhibitors will receive an official approval email. After receiving IAAPA approval, exhibitors and their Exhibitor Appointed Contractor (EAC) **must submit the approved booth layout to BLG** for the required structural review and health and safety inspection via email: operations@blg-events.com

IAAPA has appointed BLG Event Management as the independent party responsible for ensuring that all booth designs comply with ADNEC's structural, technical and safety standards. BLG specializes in venue compliance, structural assessment and onsite safety management, and their review is required to meet ADNEC regulations.

BLG will charge an inspection fee of AED 155 for space-only stands, AED 200 for complex stands and AED 220 for double-deck stands, all subject to 5 percent VAT.

Insurance

IAAPA has contracted a basic general liability policy on behalf of each exhibitor of US\$2 million general aggregate and US\$1 million per occurrence coverage. This covers each exhibiting company, so they are not required to submit a customized certificate with show information to IAAPA for review.

However, any exhibitor displaying an amusement ride or device (per ASTM EN 13814 Group of Standards) which allows audience participation, using flammable materials, or serving food or beverage items that is the exhibitor's own product, will need to carry an equivalent of US\$3 million general aggregate and US\$2 million per occurrence and provide IAAPA with a copy of that certificate via the [Audience Participation Safety Form & Ride Registration](#) or via email at exhibitors@IAAPA.org by **13 February**. As well, all Non-Official/ Exhibitor Appointed Contractor (EAC) are required to carry and submit a COI as outlined [here](#).
