### Show Your Commitment to Sustainability and Take the Exhibitor Sustainability Pledge

IAAPA's board of directors has committed to increasing sustainability measures at IAAPA and our Expos. ### Audience Participation Safety Form/Ride Registration

ALL Exhibitors, regardless of display items, must complete the online [Audience Participation Safety Form](#) by **13 February 2026** to indicate if they are bringing a dynamic device or not. A dynamic device is a product or device that moves a participant through a fixed course. Coin-op products are exempt. Click [here](#) for more information.

All exhibitors are reminded to complete and submit the **compulsory forms** listed in the [Exhibitor Services Guide](#) by the stated deadlines. This includes [booth layout](#) and [safety/ride registration](#).
